6	application will be submitted in 2008 for implementation of the plan through June 30,						
7	2009 – June 29, 2012.						
8	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts,						
9	approves and authorizes expenditures in the following;						
10	1. The U.S. Department of Health and Human Services, Centers for Disease Control						
11	and Prevention (CDC) grant award of \$120,848 for budget period June 30, 2007 –						
12	June 29, 2008 with attached budget.						
13	BE IT FURTHER RESOLVED that funds will be utilized by the Tohono O'odham Department of						
14	Health and Human Services to develop a plan for coordinated Cancer Prevention and						
15	Control.						
16	BE IT FINALLY resolved that the Tohono O'odham Nation officials to wit: The Chairperson or any						
17	designated official is hereby authorized to negotiate and execute the grant, provided						
18	however, that any amendments affecting the funding or funding level shall be						
19	submitted for approval by the Legislative Council.
