

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the U.S Department of Health and Human Services Centers for Disease  
Control and Prevention (CDC) Comprehensive Cancer Planning Grant Award)**

**RESOLUTION NO. 07-767**

1 **WHEREAS, cancer is an increasing health risk for members of the Tohono O'odham Nation; and**  
2 **WHEREAS, it is important to develop a comprehensive plan to address this health risk; and**  
3 **WHEREAS, a five year grant was awarded to the Tohono O'odham Department of Health and**  
4 **Human Services beginning June 30, 2007 – June 29, 2012, the first year is a one year**  
5 **planning grant to start June 30, 2007 - June 29, 2008 in the amount of \$120,484.00. An**  
6 **application will be submitted in 2008 for implementation of the plan through June 30,**  
7 **2009 – June 29, 2012.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts,**  
9 **approves and authorizes expenditures in the following;**

- 10 **1. The U.S. Department of Health and Human Services, Centers for Disease Control**  
11 **and Prevention (CDC) grant award of \$120,848 for budget period June 30, 2007 –**  
12 **June 29, 2008 with attached budget.**

13 **BE IT FURTHER RESOLVED that funds will be utilized by the Tohono O'odham Department of**  
14 **Health and Human Services to develop a plan for coordinated Cancer Prevention and**  
15 **Control.**

16 **BE IT FINALLY resolved that the Tohono O'odham Nation officials to wit: The Chairperson or any**  
17 **designated official is hereby authorized to negotiate and execute the grant, provided**  
18 **however, that any amendments affecting the funding or funding level shall be**  
19 **submitted for approval by the Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day**  
21 **of DECEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (i) & (j) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**




