

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2008 Budget Amendment #1 for the Topawa Community,
utilizing FY 2003 and 2007 carry over monies)**

RESOLUTION NO. 07-768

1 **WHEREAS, on November 13, 2007, at a scheduled meeting of the Baboquivari District Council, the**
2 **Topawa Community Representatives presented a budget amendment #1 to the FY 2008**
3 **Topawa Community budget; and**

4 **WHEREAS, at a community meeting on November 07, 2007, the Topawa Community members,**
5 **accepted and approved to amend the Topawa Community FY 2008 budget; and**

6 **WHEREAS, the Topawa Community is utilizing unused dollars from FY 2003 in the amount of**
7 **\$5,597.97 and \$109,616.41 from the FY 2007 budget line items 727.32 (\$26,401.72),**
8 **750.32 (\$55,224.69) and 810.32 (\$27,990.00) to be carried forward; and**

9 **WHEREAS, this amendment #1 will increase the amounts in the following line items:**

22 **will increase Topawa Community FY 2008 Budget to \$234,512.56; and will also increase**
23 **the Baboquivari District FY 2008 budget from \$1,192,981.78 to \$1,308,196.16; and**

24 **WHEREAS, this amendment #1 will deplete Topawa Community's unused dollars from FY 2003**
25 **and FY 2007, Line item 727.32 (\$26,401.72); Line item 750.32 (\$55,224.69); Line item**
26 **810.32 (\$27,990.00).**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
28 **Topawa Community FY 2008 Budget Amendment #1, utilizing unused dollars from FY**
29 **2003 (\$5,597.97) and FY 2007 (\$109,616.41), totaling \$115,214.38 to the original budget**
30 **of \$119,298.18, for a new total FY 2008 Topawa Community budget of \$234,512.56, and**
31 **to amend the \$115,214.38 to the above mentioned line items.**

5 **Budget FY 2008 will be reviewed and approved by the Budget and Finance Committee**
6 **and the Tohono O'odham Legislative Council.**

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day**
8 **of DECEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and 199.2[03] ABSENT, pursuant to the powers vested in the Council by**
10 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
11 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
13 **18, 1934 (48 Stat. 984).**


