5 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council does hereby
6 recognize that the above-named person(s) have relinquished their membership in
7 this Nation, and does hereby order that their name(s) be deleted from the
8 membership roll.

9 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH. Day
10 of JANUARY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
11 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by
12 Article II, Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'odham
13 Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting
14 Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16
15 of the Act of June 18, 1934 (48 Stat. 984).


