

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval to expend FY2007 carry forward funds from the Desert Diamond Casinos, in the amount of \$32,512.37, for the FY2008 Cultural Center & Museum budget 44-1516)**

RESOLUTION NO. 08-021

1 WHEREAS, the Tohono O'odham Legislative Council approved a contribution from the Desert  
2 Diamond Casinos, in the amount of \$54,016.25, for the FY 2007 Cultural Center &  
3 Museum budget 44-1516 by Council Resolution No. 06-0804; and

4 WHEREAS, the FY2007 carry forward funds from the Desert Diamond Casinos total \$32,512.37; and

5 WHEREAS, the request to expend FY 2007 carry forward funds from the Desert Diamond Casinos  
6 for the FY2008 Cultural Center & Museum budget 44-1516 has been reviewed by the  
7 Legislative Cultural Preservation Committee and the Legislative Budget and Finance  
8 Committee.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
10 the expenditure of FY2007 carry forward funds from the Desert Diamond Casinos, in  
11 the amount of \$32,512.37, in accordance with the Cultural Center & Museum budget  
12 44-1516 attached hereto.

13 BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the  
14 Chairman and any designated official to expend and administer the budget, as  
15 attached, provided that any amendments affecting the funds or funding levels of the  
16 budget shall be submitted for further prior approval by the Tohono O'odham  
17 Legislative Council.

18 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>. Day  
19 of JANUARY, 2008 at a meeting at which a quorum was present with a vote of 2,362.5 FOR; -0-  
20 AGAINST; -0- NOT VOTING; and 172.0 [08] ABSENT, pursuant to the powers vested in the Council by  
21 Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
22 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
23 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
24 18, 1934 (48 Stat. 984).
