

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Gu Achi District Fiscal Year 2008 Budget Amendment #1)**

RESOLUTION NO. 08-044

1 **WHEREAS, the Tohono O'odham Legislative Council established a quorum during the February**
2 **General Session to address issues pertaining to the nation; and**

3 **WHEREAS, the Tohono O'odham Legislative Council had passed Resolution #07-461 "Approving**
4 ***FY 2008 Apportionment of Gaming Revenues to Districts by Equal Distribution*" with**
5 **an amount of \$1,192,981.78; and**

6 **WHEREAS, the Tohono O'odham Legislative Council had also passed Resolution #07-552**
7 ***"Approving Gu Achi District Fiscal Year 2008 Budget of \$1,192,981.78" which does state***
8 ***that the "Gu Achi District has the authority to modify its FY 2008 budget in accordance***
9 ***with protocols set forth by this Council. Any amendments affecting the funds or***
10 ***funding levels of the Gu Achi District FY 2008 budget shall be approved by the Tohono***
11 ***O'odham Legislative Council.*"; and**

12 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution #07-764 "Approving FY**
13 ***2008 Additional Apportionment of Gaming Revenues to Districts*" for additional**
14 **apportionments from the gaming revenues which also includes interest earned to**
15 **each of the eleven political districts; and**

16 **WHEREAS, the Gu Achi District Council established a quorum at a regularly scheduled meeting**
17 **in the Community of Florence on January 26, 2008 to address issues pertaining to**
18 **district matters.**

19 **WHEREAS, the Gu Achi District Council did pass the proposed amendment for their Gu Achi**
20 **District Fiscal Year 2008 Budget Amendment #1.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
22 **the Gu Achi District Fiscal Year 2008 Budget Amendment #1 as attached hereto.**

23 **BE IT FINALLY RESOLVED that the Gu Achi District reserves the right to modify its Fiscal Year**
24 **2008 budget according to the Tohono O'odham Nation's process, but any**
25 **amendments affecting the funds or funding levels shall be approved by the Tohono**
26 **O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**
28 **of FEBRUARY, 2008 at a meeting at which a quorum was present with a vote of 2,269.7 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and 264.8 [04] ABSENT, pursuant to the powers vested in the Council by**
30 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
31 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
33 **18, 1934 (48 Stat. 984).**
