

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2008 Budget Amendment No.1 for the Tohono O'odham Nation Police**  
**Department using salary savings to cover cost of contract beds for the Corrections facility**  
**and to increase line item 711- Communications by deleting line item 750)**

RESOLUTION NO. 08-047

1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has savings derived from**  
2 **vacant positions from Oct 1, 2007 to January 31, 2008 in the amount of \$29,555.45**  
3 **leaving eight (8) months salary available for new personnel; and**

4 **WHEREAS, the TONPD has agreed to cost share with utilization of contract beds at a total amount**  
5 **of \$233,280.00; and**

6 **WHEREAS, the TONPD has agreed to fund part of the cost at a total of \$29,227.59 to be added to**  
7 **line item 810-Professional services with the remaining amount of \$327.86 to be added**  
8 **to line item 711 - Communications; and**

9 **WHEREAS, the TONPD has also deleted line item 750 - Capitol in the amount of \$10,000.00 to be**  
10 **put into line item 711 - Communications to cover the cost of phone services which**  
11 **brings the total amount added to the communications line item to the amount of**  
12 **\$10,327.86; and**

13 **WHEREAS, this is recognized as a temporary funding solution that will require special funding for**  
14 **next fiscal year.**

15 **NOW, THEREFORE, BE IT RESOLVED that Tohono O'odham Legislative Council hereby accepts,**  
16 **approves, and authorizes the FY 2008 Law Enforcement Budget Amendment No. 1 as**  
17 **follows:**

- 18 **1. Use of salary savings of \$29,555.45 for cost of contract beds to be cost Shared with**  
19 **the Corrections budget.**
- 20 **2. To delete line item 750 - Capitol by \$10,000.00 and move funds to line item 711 -**  
21 **Communications.**
- 22 **3. To increase line item 711 - Communications by \$10,327.86.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**  
24 **Chairman and any designated official to expend and administer the budget as**  
25 **attached, provided that any amendments affecting the funds or funding level shall be**  
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>. Day**  
28 **of FEBRUARY, 2008 at a meeting at which a quorum was present with a vote of 2,269.7 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and 264.8 [04] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
33 **Stat. 984).**
