

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the FY 08 Solid Waste Management Program BLM Budget 00-000,  
in the amount of \$14,000)**

**RESOLUTION NO. 08-049**

1 WHEREAS, the Tohono O'odham Legislative Council approved a US Bureau of Land Management  
2 grant, in the amount of \$14,000 through Resolution 07-651; and

3 WHEREAS, the Solid Waste Management Program will submit the FY08 BLM budget 00-0000, in the  
4 amount of \$14,000; and

5 WHEREAS, the FY08 Solid Waste Management Program BLM budget 00-0000 has been reviewed  
6 by the Tohono O'odham Legislative Natural Resources Committee and the Budget and  
7 Finance Committee.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the  
9 FY08 Solid Waste Management Program BLM budget 00-0000, in the amount of  
10 \$14,000, in accordance in the budget attached hereto.

11 BE IT FINALLY RESOLVED by the Tohono Legislative Council that the Tohono O'odham Nation's  
12 Officials, to wit: the Chairperson and any designated official are authorized to  
13 negotiate and administer the budget, provided however, that any amendments  
14 affecting the funds or funding levels of the budget shall be submitted for further prior  
15 approval.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup>. Day  
17 of FEBRUARY, 2008 at a meeting at which a quorum was present with a vote of 2,269.7 FOR; -0-  
18 AGAINST; -0- NOT VOTING; and 264.8 [04] ABSENT, pursuant to the powers vested in the Council by  
19 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
20 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
21 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
22 18, 1934 (48 Stat. 984).




