

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving 2008 Budget Amendment #1 for Artesia/Little Tucson Community to
Carryover Monies From FY's 2001, 2002 and 2006)**

RESOLUTION NO. 08-055

1 **WHEREAS, at a regular scheduled meeting of the Baboquivari District Council, held on January**
2 **16, 2008, at which a quorum was present, the Artesia/Little Tucson Community**
3 **Representatives presented a budget amendment #1 to their 2008 budget; and**

4 **WHEREAS, at a Artesia/Little Tucson Community meeting, held on November 5, 2007, the budget**
5 **amendment #1 to carryover \$9,823.01 from FY 2001; \$33,995.91 from FY 2002; and**
6 **\$58,773.41 from FY 2006, for a total amount of \$102,592.33, was presented and**
7 **approved by the Artesia/Little Tucson Community members, by a vote count of 11-FOR;**
8 **0-AGAINST; and 0-NOT VOTING; and**

9 **WHEREAS, the budget amendment #1 will apply as follows:**

22 **Community budget of \$119,298.18 by \$102,592.33, for a total amended amount of**
23 **\$221,890.51; and**

24 **WHEREAS, this budget amendment #1 will also increase the current Baboquivari District 2008**
25 **budget of \$1,529,900.02 to \$1,632,492.32; and**

26 **WHEREAS, this will deplete carryover monies from FY's 2001, 2002 and 2006 for Artesia/Little**
27 **Tucson Community.**

28 **NOW, THEREFORE BE IT RESOLVED the Tohono O'odham Legislative Council approves**
29 **Artesia/Little Tucson Community's 2008 budget amendment #1, to carryover \$9,823.01**
30 **from FY 2001; \$33,995.91 from FY 2002; and \$58,773.41 from FY 2006, for a total amount**
31 **of \$102,592.33 and amend to their original 2008 budget for a total amended budget**
32 **amount of \$221,890.51 and also increases the Baboquivari District 2008 budget of**
33 **\$1,529,900.02 to \$1,632,492.32.**

8 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
9 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
10 **18, 1934 (48 Stat. 984).**
