

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating the FY 2008 Supplemental request for the General
Support Services-Motor Pool in the amount of \$413,305.16)**

RESOLUTION NO. 08-073

- 1 **WHEREAS, the Tohono O'odham Nation (Nation's) General Support Services consist of Motor Pool,**
2 **Accounting, Property & Supply, Human Resources, Grants & Contracts, Facility**
3 **Maintenance and the Department of Information & Technology; and**
- 4 **WHEREAS, the General Support Services provide support to each of the Nations Departments,**
5 **Programs & Offices; and**
- 6 **WHEREAS, within the past ten years the Nations tribal government and services has grown**
7 **immensely that include an increase in personnel, offices, buildings, vehicles and**
8 **equipment; and**
- 9 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to all**
10 **General Support Services Programs in order to ensure that our government's**
11 **infrastructure is secure to provide optimum services for all of the Nations**
12 **Departments and Programs; and**
- 13 **WHEREAS, the Nations Motor Pool has not received added resources for the past ten years and has**
14 **experienced an increase in the Nations vehicle fleet of 900 vehicles.**
- 15 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approves and**
16 **appropriates for the FY 2008 Supplemental request for the General Support Services-**
17 **Motor Pool in the total amount of \$413,305.16 from the General Fund.**
- 18 **BE IT FURTHER RESOLVED that line items 610,620,630 in the subtotal amount of \$158,305.16 shall**
19 **be a reoccurring appropriation for future fiscal years and does hereby add to the FY**
20 **2008 Motor Pool Base Budget.**
- 21 **BE IT FURTHER RESOLVED that line items 750 and 778 in the subtotal amount of \$255,000.00 shall**
22 **be for a one-time funding appropriation for FY 2008 and any unexpended funds from**
23 **the one-time appropriation that has been obligated during FY 2008 may be considered**
24 **for carry-over after review by the Executive Office and the Budget & Finance**
25 **Committee and approval by the Tohono O'odham Legislative Council.**
- 26 **BE IT FURTHER RESOLVED that all salaries within this budget shall be prorated at the date of**
27 **approval of this Resolution.**
- 28 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
29 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**
30 **administer the attached budget, provided, however that any amendments affecting**
31 **theses funds or funding levels that are budgeted shall be submitted for prior approval**
32 **by the Tohono O'odham Legislative Council.**


