

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating the Supplemental request for the General Support
Services-Motor Pool in the amount of \$3,500,000.00 for Construction)

RESOLUTION NO. 08-074

1 **WHEREAS, the Tohono O'odham Nation (Nation's) General Support Services consist of Motor Pool,**
2 **Accounting, Property & Supply, Human Resources, Grants & Contracts, Facility**
3 **Maintenance and the Department of Information & Technology; and**

4 **WHEREAS, the General Support Services provide support to each of the Nations Departments,**
5 **Programs & Offices; and**

6 **WHEREAS, within the past ten years the Nation's tribal government and services has grown**
7 **immensely that include an increase in personnel, offices, buildings, vehicles and**
8 **equipment; and**

9 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to all**
10 **General Support Services Programs in order to ensure that our government's**
11 **infrastructure to provide optimum services for all of the Nations Departments and**
12 **Programs; and**

13 **WHEREAS, the Nations Motor Pool has not received added resources for the past ten years and has**
14 **experienced an increase in the Nations vehicle fleet of 900 vehicles.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approve and**
16 **appropriates \$3,500,000.00 for construction from Nation's general fund revenues to**
17 **fund the attached budget for the Nations Motor Pool for General Support Services.**

18 **BE IT FURTHER RESOLVED that the \$3,500,000.00 shall be placed within a separate fund solely for**
19 **the purposes approved for Motor Pool in accordance with the attached budget and**
20 **shall carryover these funds if required to complete full construction as budgeted.**

21 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
22 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**
23 **administer the attached budget, provided, however that any amendments affecting**
24 **theses funds or funding levels that are budgeted shall be submitted for prior approval**
25 **by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH. Day**
27 **of FEBRUARY, 2008 at a meeting at which a quorum was present with a vote of 2,066.4 FOR; 468.1**
28 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
29 **Section I (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
30 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
32 **18, 1934 (48 Stat. 984).**
