

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating the FY 2008 Supplemental request for the General Support Services - Accounting & Property & Supply in the amount of \$600,716.37)

RESOLUTION NO. 08-075

1 **WHEREAS, the Tohono O'odham Nation (Nation's) General Support Services consist of Motor Pool,**
2 **Accounting, Property & Supply, Human Resources, Grants & Contracts, Facility**
3 **Maintenance and the Department of Information & Technology; and**

4 **WHEREAS the General Support Services provide support to each of the Nation's Departments,**
5 **Programs & Offices; and**

6 **WHEREAS, within the past ten years the Nation's tribal government and services has grown**
7 **immensely that include an increase in personnel, offices, buildings, vehicles and**
8 **equipment; and**

9 **WHEREAS, the Nation's leaders have determined it necessary to provide added resources to all**
10 **General Support Services Programs in order to ensure that our government's**
11 **infrastructnre is secnre to provide optimum services for all of the Nation's**
12 **Departments and Programs; and**

13 **WHEREAS, the Nation's Accounting Department and Property & Supply has not received added**
14 **resourcnes for the past ten years and has experienced an increase in the Nation's**
15 **procnremnt and finaancial management for the Nation's programs and offices.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby approves and**
17 **appropriates for the FY 2008 Supplemental request for the General Support Services**
18 **- Accounting and Property & Supply in the total amount of \$600,716.37 from the**
19 **General Fund.**

20 **BE IT FURTHER RESOLVED that line items 610, 620, 650, 721 and 810 in the subtotal amount of**
21 **\$427,143.12 shall be a reoccnrring appropriations for fnture fiscal years and does**
22 **hereby add to the FY 2008 Acconnting and Property & Supply Base Budget.**

23 **BE IT FURTHER RESOLVED that line items 750 and 778 in the subtotal amount of**
24 **\$173,573.25 shall be for a one-time funding appropriation for FY 2008 and any**
25 **nnexpended funds from the one-time appropriation that has been obligated during**
26 **FY 2008 may be considered for carry-over after review by the Executive Office and the**
27 **Budget & Finance Committee and approval by the Tohono O'odham Legislative**
28 **Council.**

29 **BE IT FURTHER RESOLVED that all salaries within this bndget shall be prorated at the date of**
30 **approval of this Resolution.**

31 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
32 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**
33 **administer the attached budget, provided however, that any amendments affecting**
