

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating the FY 2008 Supplemental request for the Office of the
Treasurer in the amount of \$1,087,960.16)

RESOLUTION NO. 08-077

1 **WHEREAS, the Tohono O'odham Nation (Nation's) Office of the Treasurer provides services for**
2 **each of the Nations Departments, Programs and Offices; and**

3 **WHEREAS, within the past ten years the Nations tribal government and services has grown**
4 **immensely that include an increase in personnel, offices, financial transactions and**
5 **need for security measures for the Nations finances; and**

6 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to all**
7 **General Support Services Programs including the Office of the Treasurer in order to**
8 **ensure that our government's infrastructure is secure to provide optimum services**
9 **for all of the Nations Departments and Programs; and**

10 **WHEREAS, the Nations Office of the Treasurer has not received added resources for the past ten**
11 **years and has experienced an increase in the Nations procurement and financial**
12 **management for the Nations programs and offices.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approves and**
14 **appropriates for the FY 2008 Supplemental request for the Office of the Treasurer in**
15 **the total amount of \$1,087,960.16 from the General Fund.**

16 **BE IT FURTHER RESOLVED that line items 610, 620, and 650 in the subtotal amount of \$114,009.19**
17 **shall be a reoccurring appropriations for future fiscal years and does hereby add to**
18 **the FY 2008 Office of the Treasurer Base Budget**

19 **BE IT FURTHER RESOLVED that line items 721 and 750 in the subtotal amount of \$973,950.97 shall**
20 **be for a one-time funding appropriation for FY 2008 and any unexpended funds from**
21 **the one-time appropriation that has been obligated during FY 2008 may be considered**
22 **for carry-over after review by the Executive Office and the Budget & Finance**
23 **Committee and approval by the Tohono O'odham Legislative Council.**

24 **BE IT FURTHER RESOLVED that this supplemental and all salaries within the budget shall be**
25 **prorated at the date of approval of this Resolution.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
27 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**
28 **administer the attached budget, provided, however that any amendments affecting**
29 **the funds or funding levels that are budgeted shall be submitted for prior approval by**
30 **the Tohono O'odham Legislative Council.**
