

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating the FY 2008 Supplemental request for the General Support
Services-Grants & Contracts Purchasing in the amount of \$352,355.31)**

RESOLUTION NO. 08-078

1 **WHEREAS, the Tohono O'odham Nation (Nation's) General Support Services consist of Motor Pool,**
2 **Accounting, Property & Supply, Human Resources, Grants & Contracts, Facility**
3 **Maintenance and the Department of Information & Technology; and**

4 **WHEREAS, the General Support Services provide support to each of the Nations Departments,**
5 **Programs & Offices; and**

6 **WHEREAS, within the past ten years the Nations tribal government and services has grown**
7 **immensely that include an increase in personnel, offices, buildings, vehicles and**
8 **equipment; and**

9 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to all**
10 **General Support Services Programs in order to ensure that our government's**
11 **infrastructure is secure to provide optimum services for all of the Nations**
12 **Departments and Programs; and**

13 **WHEREAS, the Nations Grants & Contracts Purchasing has not received added resources for the**
14 **past ten years and has experienced an increase in the Nations grants and contracts**
15 **and an increase in the amount of purchasing being done by the Nation.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approves and**
17 **appropriates for the FY 2008 Supplemental request for the General Support Services**
18 **- Grants & Contracts Purchasing in the total amount of \$352,355.31 from the General**
19 **Fund.**

20 **BE IT FURTHER RESOLVED that line items 610 and 620 in the subtotal amount of \$307,655.31 shall**
21 **be a reoccurring appropriations for future fiscal years and does hereby add to the FY**
22 **2008 Grants & Contracts Purchasing Base Budget.**

23 **BE IT FURTHER RESOLVED that line item 721 in the subtotal amount of \$44,700.00 shall be for a**
24 **one-time funding appropriation for FY 2008 and all unexpended funds shall be**
25 **returned to the General Fund.**

26 **BE IT FURTHER RESOLVED that this supplemental and all salaries within the budget shall be**
27 **prorated at the date of approval of this Resolution.**

2 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**
3 **administer the attached budget, provided, however that any amendments affecting**
4 **the funds or funding levels that are budgeted shall be submitted for prior approval by**
5 **the Tohono O'odham Legislative Council.**

6 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH. Day**
7 **of FEBRUARY, 2008 at a meeting at which a quorum was present with a vote of 2,306.6 FOR; -0-**
8 **AGAINST; 227.9 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
9 **Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
10 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
12 **18, 1934 (48 Stat. 984).**
