(Approving and Appropriating the FY 2008 Supplemental request for the General Support Services- Department of Information & Technology in the amount of \$1,759,823.74)

RESOLUTION NO. 08-079

1 **WHEREAS, the Tohono O'odham Nation (Nation's) General Support Services consist of Motor Pool,**
2 **Accounting, Property & Supply, Human Resources, Grants & Contracts, Facility**
3 **Maintenance and the Department of Information & Technology; and**

4 **WHEREAS, the General Support Services provide support to each of the Nations Departments,**
5 **Programs & Offices; and**

6 **WHEREAS, within the past ten years the Nations tribal government and services has grown**
7 **immensely that include an increase in personnel, offices, buildings, vehicles and**
8 **equipment; and**

9 **WHEREAS, the Nations leaders have determined It necessary to provide added resources to all**
10 **General Support Services Programs in order to ensure that our government's**
11 **infrastructure is secure to provide optimum services for all of the Nations**
12 **Departments and Programs; and**

13 **WHEREAS, the Nations Department of Information & Technology has not received added**
14 **resources for the past ten years and has experienced an increase in service calls,**
15 **equipment requests and overall technology advancement.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approves and**
17 **appropriates the FY 2008 Snpplemental request for the General Support Servclces -**
18 **Department of Information & Technology in the budget total amount of \$1,759,823.74.**

19 **BE IT FURTHER RESOLVED that line items 610,620,751,774 and 810 in the subtotal amount of**
20 **\$683,823.74 shall be a reoccurring appropriation for future fiscal years and does**
21 **hereby add to the FY 2008 Department of Information & Technology Base Budget.**

22 **BE IT FURTHER RESOLVED that line ltems 774,810 and 750 in the subtotal amount of \$1,076,000.00**
23 **shall be for a one-time funding appropriation for FY 2008 and all unexpended funds**
24 **shall be returned to the General Fund.**

25 **BE IT FURTHER RESOLVED that this supplemental aud all salaries within the budget shall be**
26 **prorated at the date of approval of this Resolution.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
28 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**
29 **administer the attached budget, provided, however that any amendments affecting**
30 **the funds or funding levels that are budgeted shall be submitted for prior approval by**
31 **the Tohono O'odham Legislative Council.**
