

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating the FY 2008 Supplemental request for the General
Support Services- Human Resources Office in the amount of \$709,412.29)**

RESOLUTION NO. 08-080

1 **WHEREAS, the Tohono O'odham Nation (Nation's) General Support Services consist of Motor Pool,**
2 **Accounting, Property & Supply, Human Resources, Grants & Contracts, Facility**
3 **Maintenance and the Department of Information & Technology; and**
4 **WHEREAS, the General Support Services provide support to each of the Nations Departments,**
5 **Programs & Offices; and**
6 **WHEREAS, within the past ten years the Nations tribal government and services has grown**
7 **immensely that include an increase in personnel, offices, buildings, vehicles and**
8 **equipment; and**
9 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to all**
10 **General Support Services Programs in order to ensure that our government's**
11 **infrastructure is secure to provide optimum services for all of the Nations**
12 **Departments and Programs; and**
13 **WHEREAS, the Nations Human Resources Offices has not received added resources for the past**
14 **ten years and has experienced an increase in the Nations personnel and service calls**
15 **from Departments & Offices.**
16 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approves and**
17 **appropriates for the FY 2008 Supplemental request for the General Support Services**
18 **- Human Resources Offices in the total amount of \$709,412.29 from the General Fund.**
19 **BE IT FURTHER RESOLVED that line items 610,620,650,660,661,810,860 and 867 in the subtotal**
20 **amount of \$431,552.29 shall be a reoccurring appropriations for future fiscal years**
21 **and does hereby add to the FY 2008 Human Resources Office Base Budget.**
22 **BE IT FURTHER RESOLVED that line items 720,721,722, 774 and 810 in the subtotal amount of**
23 **\$277,860.00 shall be for a one-time funding appropriation for FY 2008 and any**
24 **unexpended funds from the one-time appropriation that has been obligated during**
25 **FY 2008 may be considered for carry-over after review by the Executive Office and the**
26 **Budget & Finance Committee and approval by the Tohono O'odham Legislative**
27 **Council.**
28 **BE IT FURTHER RESOLVED that this supplemental and all salaries within the budget shall be**
29 **prorated at the date of approval of this Resolution.**
30 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
31 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**
32 **administer the attached budget, provided, however that any amendments affecting**
