

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating the FY 2008 Supplemental request for the General Support Services- Facility Management in the amount of \$1,399,385.58)

RESOLUTION NO. 08-081

1 **WHEREAS, the Tohono O'odham Nation (Nation's) General Support Services consist of Motor Pool,**
2 **Accounting, Property & Supply, Human Resources, Grants & Contracts, Facility**
3 **Maintenance and the Department of Information & Technology; and**

4 **WHEREAS, the General Support Services provide support to each of the Nations Departments,**
5 **Programs & Offices; and**

6 **WHEREAS, within the past ten years the Nations tribal government and services has grown**
7 **immensely that include an increase in personnel, offices, buildings, vehicles and**
8 **equipment; and**

9 **WHEREAS, the Nations leaders have determined it necessary to provide added resources to all**
10 **General Support Services Programs in order to ensure that our government's**
11 **infrastructure is secure to provide optimum services for all of the Nations**
12 **Departments and Programs; and**

13 **WHEREAS, the Nations Facility Management has not received added resources for the past ten**
14 **years and has experienced an increase in the Nations office buildings and service calls**
15 **for all departments and offices.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approves and**
17 **appropriates for the FY 2008 Supplemental request for the General Support Services**
18 **- Facility Management in the total amount of \$ 1,399,385.58.**

19 **BE IT FURTHER RESOLVED that line items 610,620,630,650, and 772 in the subtotal amount of**
20 **\$239,801.93 shall be a reoccurring appropriations for future fiscal years and does**
21 **hereby add to the FY 2008 Facility Management Base Budget.**

22 **BE IT FURTHER RESOLVED that line items 778 and 750 in the subtotal amount of \$1,159,583.65**
23 **shall be for a one-time funding appropriation for FY 2008 and any unexpended funds**
24 **from the one-time appropriation that has been obligated during FY 2008 may be**
25 **considered for carry-over after review by the Executive Office and the Budget &**
26 **Finance Committee and approval by the Tohono O'odham Legislative Council.**

27 **BE IT FURTHER RESOLVED that this supplemental and all salaries within the budget shall be**
28 **prorated at the date of approval of this Resolution.**

29 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
30 **Nation Chairman, Vice-Chairman and any designated officials are authorized to**
31 **administer the attached budget, provided, however that any amendments affecting**

1 the funds or funding levels that are budgeted shall be submitted for prior approval by
2 the Tohono O'odham Legislative Council.

4 of FEBRUARY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
5 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
6 Section 1 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
7 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
8 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
9 18, 1934 (48 Stat. 984).
