

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving an Appropriation for the Office of the Chairman & Vice Chairman for FY 2008)**

RESOLUTION NO. 08-084

1 WHEREAS, the Tohono O'odham Legislative Council approved the Fiscal Year 2008 Tribal
2 Bndgets (Resolution No. 07-588) which included the budget for the Office of the
3 Chairman & Vice Chairman; and

4 WHEREAS, the Tohono O'odham Nation Chairman and Vice Chairman have recently entered
5 into their current four-year term as elected officials and have inherited vehicles that
6 have previously been ntlized by the prior Administration that has accrued extensive
7 mileage; and

8 WHEREAS, it is necessary to replace vehicles for the Chairman and the Vice Chairman and his
9 office as they are required to drive extenslvely throughout the Tohono O'odham
10 Nation of 2.8 million acres of land and off the Nations land.

11 NOW, THEREFORE, BE IT RESOLVED that the Legislative Council does hereby approve and
12 appropriates \$124,400.00 from general fund revenues to fund the attached budget
13 for the Office of the Chairman & Vice Chairman of the Tohono O'odham Nation. --

14 BE IT FURTHER RESOLVED that this approval is for a one-time funding appropriation and that all
15 nnused funds from this appropriation is to be returned to the Nations general fund.

16 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
17 Nation Chairman, Vice-Chairman and any designated officials are authorized to
18 administer the attached bndget, provided, however that any amendments affecting
19 the funds or funding levels that are budgeted shall be submitted for prior approval
20 by the Tohono O'odham Legislative Council.

21 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH. Day
22 of FEBRUARY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
23 AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by
24 Section 1(d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
25 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
26 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
27 18, 1934 (48 Stat. 984).
