9		office as they are required to drive extensively throughout the Tohono O'odham
10		Nation of 2.8 million acres of land and off the Nations land.
11	NOW, THER	EFORE, BE IT RESOLVED that the Legislative Conncil does hereby approve and
12		appropriates \$124,400.00 from general fund revenues to fund the attached budget
13	***	for the Office of the Chairman & Vice Chairman of the Tohono O'odham Nation.
14	BE IT FURTH	ER RESOLVED that this approval is for a one-time funding appropriation and that all
15		nnused funds from this appropriation is to be returned to the Nations general fund.
16	BE IT FINALI	LY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
17		Nation Chairman, Vice-Chairman and any designated officials are anthorized to
18		administer the attached budget, provided, however that any amendments affecting
19		the funds or funding levels that are budgeted shall be submitted for prior approval
20		by the Tohono O'odham Legislative Conncil.
