

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY2008 Attorney Contract for Lawrence O. Boswell to Serve as Conflict Attorney)**

**RESOLUTION NO. 08-087**

1 **WHEREAS, there is a need for attorneys to handle conflicts which the Tohono O'odham Advocate**  
2 **Program is not ethically allowed to handle in regards to the increasing needs of tribal**  
3 **members for legal representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to contract with Larry O. Boswell to represent clients**  
5 **who cannot be represented by the Nations Advocate Program; due to the programs'**  
6 **conflict of interest.**

7 **WHEREAS, the Advocate Program has presented a contract for Larry O. Boswell which confirms**  
8 **the terms and conditions related to his services, a copy of which is attached hereto;**  
9 **and**

10 **WHEREAS, the Domestic Affairs Committee has recommended approval by the Legislative Council**  
11 **of a Conflict Attorney Contract with Larry O. Boswell on such terms.**

12 **NOW, THEREFORE BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves the**  
13 **Conflict Attorney Contract for Larry O. Boswell in substantially the form attached**  
14 **hereto for the period of October 1, 2007 through September 30, 2008 in an amount not**  
15 **to exceed \$75,000.**

16 **BE IT FINALLY RESOLVED THAT Funding for the Conflict Attorney Contract for Larry O. Boswell**  
17 **shall be provided under the operating budget of the Tohono O'odham Advocate**  
18 **Program from fiscal year 2008.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup>. Day**  
20 **of FEBRUARY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
23 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
25 **18, 1934 (48 Stat. 984).**
