8	the terms and conditions related to his services, a copy of which is attached hereto;

10	WHEREAS, the Domestic Affairs Committee has recommended approval by the Legislative Council
11	of a Conflict Attorney Contract with Larry O. Boswell on such terms.
12	NOW, THEREFORE BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves the
13	Conflict Attorney Contract for Larry O. Boswell in substantially the form attached
14	hereto for the period of October 1, 2007 through September 30, 2008 in an amount not
15	to exceed \$75,000.
16	BE IT FINALLY RESOLVED THAT Funding for the Conflict Attorney Contract for Larry O. Boswell
17	shall be provided under the operating budget of the Tohono O'odham Advocate
18	Program from fiscal year 2008.
