RESOLUTION NO. 08-088

1 WHEREAS, the Tohono O'odham Advocate Program ("Program") presented its proposal for an
2 Attorney Contract with Heidi Norton at an Emergency Session of the Tohono O'odham
3 Legislative Council ("Council") on February 19, 2008; and

4 WHEREAS, the Council passed Resolution No. 08-086 Approving the FY08 Attorney Contract with
5 Heidi Norton which contained the confidential names of the clients; and

6 WHEREAS, Councilman Timothy Joaquin entertained a motion to amend the resolution to remove
7 the names from the Resolution and from the Record; and

8 WHEREAS, the Council voted and approved the motion to amend.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the
10 motion to amend Resolution No. 08-086, removing the client names from the
11 Resolution and from the Record.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH. Day
13 of FEBRUARY, 2008 at a meeting at which a quorum was present with a vote of 2,089.8 FOR; -0-
14 AGAINST; 444.7 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
15 Section 1(l) and 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June
18 18, 1934 (48 Stat. 984).
