9	hereto; and
10	$\textbf{WHEREAS}, \ \textbf{the Domestic Affairs Committee has recommended approval by the Legislative Council}$
11	of a Conflict Attorney Contract with Michelle K. Don Carlos on such terms.
12	NOW, THEREFORE BE IT RESOLVED THAT the Tohono O'odham Legislative Conncil approves the
13	Conflict Attorney Contract for Michelle K. Don Carlos in snbstantially the form
14	attached hereto for the period of October 1, 2007 through September 30, 2008 in an
15	amount not to exceed \$35,000.

17	Carlos shall be provided under the operating budget of the Tohono O'odham ${f Advocate}$
