1	WHEREAS, there is a need for attorneys to handle conflicts which the Tohono O'odham Advocate
2	Program is not ethically allowed to handle in regards to the increasing needs of tribal
3	members for legal representation in civil and criminal matters; and
4	   WHEREAS, the Advocate Program wishes to contract with John M. Neis to represent clients with
5	who cannot be represented by the Nation's Advocate Program; due to the programs'
6	conflict of interest.
7	WHEREAS, the Advocate Program has presented a contract for John M. Neis which confirms the
8	terms and conditions related to his services, a copy of which is attached hereto; and
9	WHEREAS, the Domestic Affairs Committee has recommended approval by the Legislative Council
10	of a Conflict Attorney Contract with John M. Nels on such terms.
11	NOW, THEREFORE BE IT RESOLVED THAT the Tohono O'odham Legislative Council approves the
12	Conflict Attorney Contract for John M. Neis in substantially the form attached hereto
13	for the period of October 1, 2007 through September 30, 2008 in an amount not to
14	exceed \$10,000.
15	BE IT FINALLY RESOLVED THAT the funding source for the Conflict Attorney Contract for John M.
16	Neis shall be provided under the operating budget of the Tohono O'odham Advocate
17	Program from fiscal year 2008.
