

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the FY 2008 DHHS-Division of Community Health/Susan G. Komen**  
**Breast Cancer Awareness Project 90 Day Extension)**

**RESOLUTION NO. 08-093**

1 **WHEREAS, the Tohono O'odham Nation Community Health Division received funding from the**  
2 **Susan G. Komen Breast Cancer Foundation to conduct the Breast Cancer Awareness**  
3 **Project to promote breast health and increase utilization of breast cancer screening**  
4 **among Tohono O'odham women over age 40; and**

5 **WHEREAS, the funding in the amount of \$33,482, approved by Resolution No. 07-254, was not**  
6 **utilized within the one year grant duration from December 1, 2006 through November**  
7 **30, 2007; and**

8 **WHEREAS, the Susan G. Komen Foundation has approved a 90-day extension of the grant**  
9 **duration, through February 29, 2008, in the amount of one-half of the original grant**  
10 **award, or \$16,742.00.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
12 **authorizes the acceptance, authorizes implementation, and expenditures of the**  
13 **following:**

- 14 **1. The Susan G. Komen Breast Cancer Foundation Extension Award in accordance with**  
15 **the attached budget in the amount of \$16,742.**
- 16 **2. The duration of this extension shall be from December 1, 2007 and remain in effect**  
17 **for 90 days through February 29, 2008.**

18 **BE IT FINALLY RESOLVED by the Tohono O'odham Nation Legislative Council that the Tohono**  
19 **O'odham Nation Official, to wit: the Chairperson or any designated official is hereby**  
20 **authorized to negotiate and execute the grant, provided however, that any**  
21 **amendment affecting the funding or funding levels shall be submitted for approval**  
22 **by the Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>TH</sup>. Day**  
24 **of FEBRUARY, 2008 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and 199.2 [04] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 1 (d)(2) & (3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
27 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
28 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**  
29 **of June 18, 1934 (48 Stat. 984).**


