6	WHEREAS,	an initial Per Capita Distribution under the first Per Capita Plan was approved on			
7		December 18, 1997 by the Phoenix Area Office of the Bureau of Indian Affairs; and			
8	WHEREAS,	initial Per Capita distribution have been and continue to be disbursed to Adult			
9		Eligible members under the first Per Capita Plan; and			
10	WHEREAS,	pursuant to the Initiative Resolution No. 2000-269 and 2000-472, the Legislative			
11		Council adopted (1) a Second Initiative Funding and Implementation Plan, (2) a			
12		Second Revenue Allocation Plan, and (3) Amendment No. 1 to each Plan (collectively			
13		the "Second Per Capita Plan"); and			
14	WHEREAS,	under the second Per Capita Plan each eligible member who is certified as eligible is			
15		entitled to receive a per capita payment of \$2,000.00; and			
16	WHEREAS,	by letter dated October 25, 2000 the Deputy Commissioner of Indian Affairs approved			
17		the Second Per Capita Plan; and			
18	WHEREAS,	as required by the Second Per Capita Plan, the Attorney General of the Nation is sued			
19		a Notice of Compliance on October 26, 2000; and			
20	WHEREAS,	as required by the Second Per Capita Plan the Enrollment Office has filed a			
21		certification of Eligible Members listing $\underline{50}$ adult eligible Members who are eligible			
22		$for receipt of a per capita \ payment \ under the terms \ of the Second \ Per \ Capita \ Plan \ and$			
23		the applicable laws of the United States and the Nation.
