

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Donation of \$3,452.00 to Lillian Hughes to Assist with Funeral Expenses)**

**LEGISLATIVE ORDER NO. 08-109**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Tohono O'odham Legislative**  
2 **Council with broad legislative and fiscal powers, including the power "to manage any**  
3 **funds within the exclusive control of the Tohono O'odham Nation, including proceeds**  
4 **derived from lands and resources of the Tohono O'odham Nation" (Constitution,**  
5 **Article VI, Section 1(d)(2)); and**

6 **WHEREAS, while the Legislative Council Chairperson is authorized to administer the Legislative**  
7 **Branch budget and approve donations in amounts up to \$800, donations greater than**  
8 **that amount must be approved by the full Legislative Council; and**

9 **WHEREAS, Lillian Hughes, an enrolled member of the Tohono O'odham Nation, has requested a**  
10 **donation from the Legislative Council to assist with burial expenses for her late**  
11 **husband, Luther Hughes; and**

12 **WHEREAS, Mr. Hughes resided on and worked for the Nation for over 25 years, and was a veteran**  
13 **of 30 years, but his surviving family members are only eligible to receive minimal**  
14 **assistance for his services; and**

15 **WHEREAS, Lillian Hughes has therefore requested assistance from the Legislative Branch.**

16 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
17 **approves a donation to Lillian Hughes from the FY 2008 Legislative Branch budget**  
18 **donations/contributions line item 852 in the amount of \$3,452.00 to assist with Luther**  
19 **Hughes' funeral expenses.**

20 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup>. Day of**  
21 **MARCH, 2008 at a meeting at which a quorum was present with a vote of 1,115.2 FOR; 558.65**  
22 **AGAINST; 480.35 NOT VOTING; and 380.3 [07] ABSENT, pursuant to the powers vested in the Council**  
23 **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'Odham Nation, adopted by the**  
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**


