

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the use of Carry Forward Funds of the US Department of Homeland Security,
Office of Grants and Training, 2006 State Homeland Security Grant #2006-GE-T6-0007
for \$82,442.63)

RESOLUTION NO. 08-111

1 **WHEREAS, the United States Department of Homeland Security has distributed grants within the**
2 **program period that was introduced on 11/01/06 to individual states, to fund**
3 **equipment purchases, training and other programs by departments that provide**
4 **public safety services within their respective jurisdictions; and**

5 **WHEREAS, Indian tribes have been designated to receive funds through the respective state for**
6 **the purpose of obligating and distributing funds from the U.S. Department of**
7 **Homeland Security, Office of Grants and Training, Homeland Security Grant Program**
8 **on a reimbursement basis to finance equipment purchases, training costs and other**
9 **needs for homeland security; and**

10 **WHEREAS, on 01/16/07, the Tohono O'odham Nation was awarded a grant from the State of**
11 **Arizona, Department of Homeland Security in the amount of \$89,000.00 as part of the**
12 **2006 grant program for the purchase of specific equipment and training needed for**
13 **enhancing the Tohono O'odham Nation Police Department SWAT Team; and**

14 **WHEREAS, the 2006 grant approval the use of carry forward of unexpended funds of \$82,442.63**
15 **has been reviewed by the Grants & Contracts Department, Executive Office, Domestic**
16 **Affairs Committee and Budget & Finance Committee, of which all recommend**
17 **acceptance of the grant award by the Legislative Council.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**
19 **approves the use of carry forward of unexpended funds for Grant No. 2006-GE-T6-0007**
20 **in the amount of \$82,442.63 on a reimbursement basis from the Tohono O'odham**
21 **Nation General Fund for the training of personnel and purchase of equipment needed**
22 **for enhancing the Tohono O'odham Nation Police Department SWAT Team and**
23 **further approves the indirect cost to administer this grant as it stipulates within the**
24 **grant program guidance.**

25 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation Police Department is authorized to**
26 **expend funds from this grant in accordance with the terms of the grant award period**
27 **of 11/01/06 to 07/31/08, with any extensions of time reasonably necessary which are**
28 **approved by the granting agency to be brought back to the Tohono O'odham**
29 **Legislative Council for approval.**

5 **Tohono O'odham Legislative Council for approval.**

7 **of MARCH, 2008 at a meeting at which a quorum was present with a vote of 2,353.4 FOR; -0-**
8 **AGAINST; -0- NOT VOTING; and 181.1[05] ABSENT, pursuant to the powers vested in the Council by**
9 **Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
10 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
11 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
12 **18, 1934 (48 Stat. 984).**
