

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance and Approval of the US Department of Homeland Security, State of
Arizona Department of Homeland Security, 2007 State Homeland Security Grant
for \$45,000.00, Grant #2007-GE-T7-0006)**

RESOLUTION NO. 08-113

1 **WHEREAS, the United States Department of Homeland Security has distributed grants to**
2 **counties, through their respective states, to fund capital purchase that provide**
3 **public safety services within their respective jurisdictions; and**

4 **WHEREAS, Indian tribes have been designated to receive funds through the respective state,**
5 **requiring tribes to sign a Letter of Offer and Acceptance; and**

6 **WHEREAS, the Tohono O'odham Nation has negotiated a Letter of Offer and Acceptance with the**
7 **State of Arizona for the purpose of obligating and distributing funds from the U.S.**
8 **Department of Homeland Security, Office of Domestic Preparedness, State Homeland**
9 **Security Grant Program on a reimbursement basis for major capital needs for**
10 **homeland security; and**

11 **WHEREAS, the Letter of Offer and Acceptance was approved in the form attached hereto by the**
12 **Tohono O'odham Legislative Council through Resolution No. 05-489 and**
13 **subsequently signed by the former Chairwoman; and**

14 **WHEREAS, the Tohono O'odham Nation has been awarded a grant from the Arizona Department**
15 **of Emergency and Military Affairs in the amount of \$45,000.00 as part of the 2007 State**
16 **Homeland Security Program Grant No. 2007-GE-T7-0006 establishing Major Capital**
17 **line item for purchase of primer vehicle; and**

18 **WHEREAS, the 2007 grant award of \$45,000.00 has been reviewed by the Office Grants &**
19 **Contracts, Executive Office, Domestic Affairs Committee and Budget & Finance**
20 **Committee, of which all recommend acceptance of the grant award by the Legislative**
21 **Council.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
23 **accepts the grant award of \$45,000.00 on a reimbursement basis from the Tohono**
24 **O'odham Nation General Fund for the purchase of a primer vehicle.**

25 **BE IT FURTHER RESOLVED that the Office of Emergency Management is authorized to expend**
26 **funds from the 2007 State Homeland Security Program Grant No. 2007-GE-T7-0006 in**
27 **the amount of \$45,000.00 in accordance with the terms of the grant award.**

28 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council authorizes the Office of**
29 **the Chairman or designee to expend funds in accordance with the terms of the grant**
30 **award period of 07/01/07 to 07/31/09 with any grant extensions of time reasonably**
