1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY07 Solid Waste Management**
2 **Program Household Hazardous Waste budget 11-5019 through Resolution No. 06-770;**
3 **and**

4 **WHEREAS, the Nation's Grants and Contracts Office has identified \$37,727.61 in carry forward**
5 **funds from the FY07 Solid Waste Management Program Household Hazardous budget**
6 **11-5019; and**

7 **WHEREAS, the Solid Waste Management Program is requesting the expenditure of the \$37,727.61**
8 **in carry forward funds from the FY07 Solid Waste Management Program Household**
9 **Hazardous Waste budget 11-5019 for the FY-08 Solid Waste Management Program**
10 **Household Hazardous budget 00-0000; and**

11 **WHEREAS, FY-08 Solid Waste Management Program Household Hazardous budget 00-0000 has**
12 **been reviewed by the Tohono O'odham Legislative Natural Resources Committee and**
13 **the Budget and Finance Committee.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
15 **the expenditure of FY-07 Solid Waste Management Program Household Hazardous**
16 **Waste carry forward funds, in the amount of \$37,727.61, for the FY-08 Solid Waste**
17 **Management Program Household Hazardous Waste budget 00-0000 in accordance**
18 **with the budget attached hereto.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairman and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding levels of the**
22 **budget shall be submitted for further prior approval by the Tohono O'odham**
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH. Day**
25 **of MARCH, 2008 at a meeting at which a quorum was present with a vote of 2,353.4 FOR; -0-**
26 **AGAINST; 181.1 NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**
