

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Tohono O'odham Nation Vocational Rehabilitation Program
FY 2007 Carryover Funds in the Amount of \$152,945.89 and Approving New Line
Item 612 Occasional Appointment into FY 2008 budget)

RESOLUTION NO. 08-124

1 **WHEREAS, the Tohono O'odham Legislative Council has previously supported the Nation's**
2 **Education Department in submitting a grant proposal that established the Vocational**
3 **Rehabilitation Program under Resolution No. 03-149; and**

4 **WHEREAS, the Tohono O'odham Nation was awarded a grant under the U.S. Department of**
5 **Education Office of Special Education Rehabilitation Services/Rehabilitation Services**
6 **Administration's Section 121 (Vocational Rehabilitation Services Projects for**
7 **American Indians with Disabilities) of the Rehabilitation Act and received grant**
8 **notification number H250D030012; and**

9 **WHEREAS, services will be provided to eligible enrolled Tohono O'odham members with**
10 **disabilities living on or near the Nation, and other federally recognized American**
11 **Indians with disabilities living on the Nation; and**

12 **WHEREAS, the services provided will be consistent with individual strengths, resources,**
13 **priorities, concerns, abilities, capabilities, and informed choice so that they may**
14 **prepare for, engage in, and maintain gainful employment; and**

15 **WHEREAS, a carryover amount has been identified from fiscal year 2007 in the amount of**
16 **\$152,945.89, and is added into the current program budget of \$400,000.00, which will**
17 **increase the total budget to \$552,945.89.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
19 **approves the Vocational Rehabilitation Program's FY 2008 Budget Amendment I**
20 **reflecting carryover funds in the amount of \$152,945.89, which will be added to the**
21 **current program budget of \$400,000.00 for a grand total of \$552,945.89.**

22 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the addition**
23 **of new line item 612 Occasional Appointment within the budget.**

24 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
25 **Nation's Official, to wit: the Chairman is authorized to execute and expend the grant**
26 **award to September 30, 2008, and provide continued culturally appropriate**
27 **vocational rehabilitation services to its clients, provided however, that any**
28 **amendments affecting the funding level of this grant shall be submitted for further**
29 **approval by the Tohono O'odham Legislative Council.**
