

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of the FY/08 Education Department – One Stop Division Budget Amendment #1)**

RESOLUTION NO. 08-126

1 **WHEREAS, the Tohono O'odham Nation's Education Department – One Stop Division PY 07 / FY 08**  
2 **Budget was developed and funded from the Department of Economic Security – State**  
3 **of Arizona Workforce Investment Act (WIA) Title 1-B through projected allocation**  
4 **effective July 01, 2007, and ending June 30, 2009 in the amount of \$212,750.00; and**

5 **WHEREAS, the PY 07 / FY 08 Education Department – One Stop Division Budget was approved**  
6 **through Tohono O'odham Legislative Council Resolution No. 07-401; and**

7 **WHEREAS, the Department of Economic Security – State of Arizona has released a final allocation**  
8 **figure to the Education Department – One Stop Division in the amount of \$279,901.00;**  
9 **and**

10 **WHEREAS, the Education Department – One Stop Division and the Grants & Contracts office has**  
11 **identified the final allocation amount as a total increase of \$67,151.00 to five (5)**  
12 **program budgets and requests to amend these budgets as identified in the following**  
13 **table and per attached budgets:**

total of \$212,750.00 by \$67,151.00 to a final allocation of \$279,901.00, as identified in the following table and per attached budgets.




The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day of MARCH, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST; -0- NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
