

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving amendment 1 to add FY07 Indian Health Service Memorandum of Agreement carry forward funds, in the amount of \$99,390.19, and line items 750 CAPITAL EQUIPMENT and 771 RM VEHICLES, to the FY08 Water Resources Study Program Indian Health Service budget 11-5016, for a total budget of \$119,390.19)**

**RESOLUTION NO. 08-130**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the FY08 Water Resources Study**  
2 **Program Indian Health Service budget 11-5016 through Resolution No. 07-624, in the**  
3 **amount of \$20,000.00; and**

4 **WHEREAS, the Nation's Grants and Contracts Office has identified \$99,390.19 in FY07 Indian**  
5 **Health Service Memorandum of Agreement carry forward funds; and**

6 **WHEREAS, the Water Resources Study Program is requesting that the FY07 carry forward, in the**  
7 **amount of \$99,390.19, be added to the FY08 Indian Health Service budget 11-5016, for**  
8 **a total budget of \$119,390.19; and**

9 **WHEREAS, the Water Resources Study Program is requesting that the line items 750 CAPITAL**  
10 **EQUIPMENT and 771 RM VEHICLES be added to the FY08 Indian Health Service budget**  
11 **11-5016; and**

12 **WHEREAS, amendment 1 to the FY08 Water Resources Study Program Indian Health Service**  
13 **budget 11-5016 has been reviewed by the Legislative Water Resources Committee and**  
14 **the Budget and Finance Committee.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
16 **amendment 1 to the FY08 Water Resources Study Program Indian Health Service**  
17 **budget 11-5016:**

18 **1) to add \$99,390.19 in FY07 Indian Health Services Memorandum of Agreement carry**  
19 **forward funds, for a total budget of \$119,390.19; and**

20 **2) to add line items 750 CAPITAL EQUIPMENT and 771 RM VEHICLES, in accordance**  
21 **with the budget attached hereto.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
23 **Chairman and any designated official to expend and administer the budget as**  
24 **attached, provided that any amendments affecting the funds or funding levels shall**  
25 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>. Day**  
27 **of MARCH, 2008 at a meeting at which a quorum was present with a vote of 2,353.4 FOR; -0-**  
28 **AGAINST; 181.1 NOT VOTING; and [07] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1(d)(2), (d)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
30 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
31 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
32 **18, 1934 (48 Stat. 984).**
