6	Nation and Pace Pacific Corporation; and
7	WHEREAS, the Attorney General has recommended that the law firm of DeConcini McDonald
8	Yetwin & Lacy be contracted to assist the Nation in resolving the construction dispute
9	over the San Simon Health Center; and
10	WHEREAS, the attached Attorney Contract has been reviewed by the Domestic Affairs Committee
11	which recommends approval by the Legislative Council.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:
13	1. Approves the Attorney Contract with DeConcini McDonald Yetwin & Lac
14	substantially in the form attached hereto, with a budget of \$25,000 to be paid fron
15	the budget account approved by Resolution No. 08-134, and an effective date o
16	February 13, 2008;
17	2. Authorizes and directs the Chairperson of the Nation to execute the Attorne
