14		$budgetamountof\$70,\!000, andterminationofthecurrentattorneycontractwiththe$
15		law firm of Chandler & Udall LLP as of February 18, 2008; and
16	WHEREAS,	funding for the attorney contract will be from the SAWRSA Trust Fund, budget account the saw of the saw o
17		number 21-2010 which has been established for water-related attorney contracts
18		under the Office of Attorney General; and
19	WHEREAS,	the Domestic Affairs, Water Resources and Budget & Finance Committees have
20		reviewed the attorney contract with Steven Weatherspoon PLLC and recommend
