(Approving FY-08 Savings Budget for Credit & Finance Program)**

**RESOLUTION NO. 08-140**

1 **WHEREAS, the Credit & Finance Program under the Planning Department is funded by BIA 638**  
2 **Master Contract; and**

3 **WHEREAS, the Credit and Finance Program has identified 638 fund savings for the following**  
4 **years:**

FY-1997 \$248,001.26

FY-1999 \$38,083.93

FY-2000 \$81,024.44

FY-2001 \$68,795.76

FY-2002 \$53,987.25

FY-2003 \$16,480.27

FY-2005 \$107,927.96

for a total savings amount of \$459,701.15; and

11 **WHEREAS, the Planning Department is requesting approval to utilize a portion of the savings**  
12 **amount for FY-08 Credit & Finance Savings Budget in the amount of \$120,887.29 for**  
13 **operational purposes and capital purchase; and**

14 **WHEREAS, the program is administered by the Planning Department's Credit and Finance**  
15 **Manager; and**

16 **WHEREAS, the FY-08 savings budget request has been reviewed by the Commerce and Budget &**  
17 **Finance Committees.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts**  
19 **and approves the BIA 638 Credit & Finance savings budget amount of \$120,887.29.**

20 **BE IT FURTHER RESOLVED that the Credit and Finance Program is authorized to expend the BIA**  
21 **638 Credit & Finance savings budget funds in the amount of \$120,887.29 upon date of**  
22 **approval of authorizing Resolution.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
24 **Chairman and any designated official to expend and administer the budget as**  
25 **attached, provided that any amendments affecting the funds or funding level shall**  
26 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup>. Day**  
28 **of MARCH, 2008 at a meeting at which a quorum was present with a vote of 2,171.0 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and 363.5 [07] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1 (d)(2), (d)(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
31 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**
