

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Rescinding Resolution No. 07-618 and Approving FY 2008 Department of Health
and Human Services Head Start Budgets)**

RESOLUTION NO. 08-141

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Head**
4 **Start Program to provide educational, health, mental health and parent involvement**
5 **services to children, three to five years of age; and**

6 **WHEREAS, the amount originally forecasted of \$1,600,069 was increased by the COLA amount of**
7 **\$24,001; and**

8 **WHEREAS, historically the Head Start grant has been divided here on the Nation into a program**
9 **budget and an administrative budget; and**

10 **WHEREAS, the grant application instructions are to have one budget for the entire amount**
11 **granted; and**

12 **WHEREAS, the Head Start Administrative Budget 11-1212 is now combined into the Head Start**
13 **Program Budget 11-1218 to match what was submitted in the 2008 Head Start Grant**
14 **Application; and**

15 **WHEREAS, this resolution adds new line items 700 Advertisement, 720 Supplies Office, 721**
16 **Supplies-other, and 810 professional services; and**

17 **WHEREAS, the Head Start Grant Award Notice restricts the Indirect Cost Charges to \$148,854 due**
18 **to the 15% administrative cap; and**

19 **WHEREAS, the Executive Branch developed and obtained committee approval of the following**
20 **budget as attached and incorporated by this reference, to be effective November 1,**
21 **2007 through October 31, 2008 and request authorization to expend funds:**

22 **1. Head Start Program Budget - \$1,475,216.00 + \$148,854.00 (IDC)= \$1,624,070.00**

23 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
24 **the above listed Head Start Program Budget and the Head Start T & TA Budget for the**
25 **Period November 1, 2007 through October 31, 2008.**

26 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
27 **Executive Branch to expend funds for the program listed above and as attached in the**
28 **amount indicated, effective November 1, 2007 through October 31, 2008.**

29 **1. Head Start Program Budget - \$1,475,216.00 + \$148,854.00 (IDC)= \$1,624,070.00**

1 **BE IT FINALLY RESOLVED** by the Tohono O'odham Legislative Council that the Tohono O'odham
2 Nation's Official, to wit, the Chairman, Vice-Chairman and any designated official are
3 authorized to negotiate and execute the grant, provided however, that any
4 amendments affecting the funds or funding levels of the grant shall be submitted for
5 further prior approval.

7 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14TH. Day**
8 **of MARCH, 2008 at a meeting at which a quorum was present with a vote of 2,353.4 FOR; -0-**
9 **AGAINST; -0- NOT VOTING; and 181.1 [07] ABSENT, pursuant to the powers vested in the Council by**
10 **Section 1 (d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
11 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
13 **18, 1934 (48 Stat. 984).**
