

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Fresno Canyon Community Budget Modification/Amendment #1)**

RESOLUTION NO. 08-145

1 WHEREAS, at a regular scheduled meeting on February 23, 2008 Fresno Canyon Community  
2 approved the carryover monies from Fiscal Year 2000 in the amount of \$51,821.59. and  
3 Fiscal Year 2001 in the amount of \$17,939.02 for a combined total of \$69,760.61. with  
4 a vote count of: 9 - FOR, 0 - AGAINST, 0 - NOT VOTING; and

5 WHEREAS, on October 2007, Fresno Canyon Community approved the carry forward monies  
6 from Fiscal Year 2007 in the amount of \$82,794.84; and

7 WHEREAS, the budget modification/amendment #1 will apply as follows:

22 WHEREAS, this budget modification/amendment #1 will increase the Fresno Canyon FY 2008  
23 original budget of \$119,298.18 to \$271,853.63 and increase the overall Baboquivari  
24 District Budget of \$1,632,492.32 to \$1,785.047.77.

25 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves  
26 Fresno Canyon Community Budget Modification/Amendment #1 to carryover monies  
27 from fiscal year 2000 in the amount of \$51,821.59 and fiscal year 2001 in the amount  
28 of \$17,939.02 for a total of \$69,760.61 & to carry forward monies from fiscal year 2007  
29 in the amount of \$82,794.84, which increases their FY 2008 budget of \$119,298.18 to  
30 \$271,853.63, and increases the overall Baboquivari District Budget of \$1,632.492.32 to  
31 \$1,785.047.77.

32 BE IT FINALLY RESOLVED that any changes in the justifications, additions, and/or the transfer of  
33 funds between budget line items are to be reviewed by the Budget and Finance  
34 Committee and approved by the Tohono O'odham Legislative Council.
