7 recognize that the above-named person(s) have relinquished their membership in  
8 this Nation, and does hereby order that their name(s) be deleted from the  
9 membership roll.

10 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup> Day  
11 of APRIL, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;  
12 -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Article II,  
13 Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted  
14 by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
15 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
16 18, 1934 (48 Stat. 984).


