Designates Sells as the distribution site for the disbursement of the 19th and 8 subsequent payouts of the third per capita checks to members of the Nation. 9 4. Authorizes the Chairman of the Nation to execute such other documents as may be 10 necessary to implement this Resolution. 11 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the disbursement of 12 funds to each additional eligible adult Tohono O'odham member is contingent upon 13 verification of a member by the Enrollment Program and further certification of 14 additional eligible members by the Tohono O'odham Legislative Council. 15 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07TH.
