

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving 2008 Budget Modification #1/Amendment #1 for GSS / Motor Pool)**

RESOLUTION NO. 08-167

1 WHEREAS, Tohono O'odham Legislative Resolution No. 07-588 adopted and approved the  
2 Executive Branch Fiscal Year 2008 Tribal Budgets; and

3 WHEREAS, Motor Pool under the General Support Services had incorrectly listed a salary for the  
4 Mechanic Supervisor position; and

5 WHEREAS, a savings does exist within the Salary and Fringe Benefits line items to cover the  
6 additional salary and fringe benefit cost.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
8 approve the amendment to the Tohono O'odham Nation Motor Pool Budget for the  
9 said position, as per attached budget.

10 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham  
11 Nation Chairman, Vice-Chairman and any designated officials are authorized to  
12 administer the Executive Branch FY 2008 Budgets, provided; however that any  
13 amendments affecting the aggregate total of the funds originally budgeted or the  
14 purposes for which the funds were budgeted to the Executive Branch FY 2008 Budget  
15 shall be submitted for prior approval by the Tohono O'odham Legislative Council.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>. Day  
17 of APRIL, 2008 at a meeting at which a quorum was present with a vote of 2,269.7 FOR; -0- AGAINST;  
18 -0- NOT VOTING; and 264.8 [07] ABSENT, pursuant to the powers vested in the Council by Section  
19 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
20 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
22 Stat. 984).


