

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the Bureau of Indian Affairs One Stop Division -477 Budget
Modification/Amendment #1)**

RESOLUTION NO. 08-174

1 **WHEREAS, the Master 477 budget provides funding for all combined federal programs under the**
2 **Education Department One Stop Division from October 1, 2006 to September 30, 2009**
3 **in the amount of \$1,195,004.13 with carry over amount; and**

4 **WHEREAS, the Master 477 budget has been developed and cost shared with the Arizona**
5 **Department of Economic Security funding to promote smooth transitional services for**
6 **clients with an effective staff cost share to promote de-centralized services; and**

7 **WHEREAS, the Master 477 budget will be modified to include carry over amount of \$146,834.96 to**
8 **reflect the identified carry over and the 477 budget is approved on a 3 year basis; and**

9 **WHEREAS, the Education Department - One Stop Division and the Grants & Contract office has**
10 **identified the carry over amount total of \$146,834.96 and requests to amend this**
11 **budget as identified per attachment budget; and**

12 **WHEREAS, the Education Department - One Stop Division Budget Amendment No. 1 also adds new**
13 **line item 750, 812 and 860 to this budget; and**

14 **WHEREAS, the Education Department - One Stop Division Budget Modification/Amendment No.**
15 **1 was reviewed by the Human Resources Development committee and the Budget &**
16 **Finance Committee.**

17 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
18 **approve and authorizes the expenditure of the Three year Master 477 Carry Over**
19 **Budget for the Education Department - One Stop Division Amendment No. 01 to**
20 **increase the budget from the original total of \$1,048,169.17 by carry over amount of**
21 **\$146,834.96 to a total amount of \$1,195,004.13 as identified per attached budget.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08TH Day**
23 **of APRIL, 2008 at a meeting at which a quorum was present with a vote of 2,335.3 FOR; -0- AGAINST;**
24 **-0- NOT VOTING; and 199.2 [05] ABSENT, pursuant to the powers vested in the Council by Section**
25 **1 (d)(2)& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
26 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
27 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
28 **Stat. 984).**
