

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting the Tohono O'odham Nation Administrative Plan 2007-2011)**

RESOLUTION NO. 08-178

1 **WHEREAS, the Constitution of the Tohono O'odham Nation, Article VII, Section 2(a) Mandates the**
2 **Chairman of the Tohono O'odham Nation to develop an Administrative Plan to be**
3 **adopted by the Tohono O'odham Legislative Council; and**

4 **WHEREAS, the Chairman of the Tohono O'odham Nation has submitted an Administrative Plan**
5 **to provide an overview of the current state of the Nation, challenges and opportunities**
6 **facing the Nation and proposed course of action for addressing the needs of the**
7 **Nation; and**

8 **WHEREAS, the Administrative Plan was presented to the Legislative Council for review,**
9 **consideration and adoption.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
11 **adopt the Administrative Plan.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
13 **of APRIL, 2008 at a meeting at which a quorum was present with a vote of 1,588.45 FOR; 749.55**
14 **AGAINST; -0- NOT VOTING; and 196.5 [04] ABSENT, pursuant to the powers vested in the Council by**
15 **Section 2 (a) of Article VII of the Constitution of the Tohono O'Odham Nation, adopted by the**
16 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
18 **18, 1934 (48 Stat. 984).**


