

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval to Amend Tohono O'odham Legislative Council Resolution No. 07-641 Titled
"Approval of the Gu-Vo District FY 2008 Budget in the Amount of \$1,192,981.78")

RESOLUTION NO. 08-187

1 **WHEREAS, an error was made in the Gu-Vo District FY 08 Budget that was not caught by the Gu-Vo**
2 **District Governing Council; and**

3 **WHEREAS the salary for one of the District Security Guards had a raise in the amount of \$0.01 per**
4 **hour; and**

5 **WHEREAS, the correct raise should have been \$0.24 per hour; and**

6 **WHEREAS, the Gu-Vo District has Salary and Fringe Benefit Savings from an Accountant position**
7 **vacant from October 1, 2007 - April 30, 2008, in the amount of \$17,336.80 in Salary and**
8 **\$4,507.49 in Fringe; and**

9 **WHEREAS, \$478.40 has been taken out of Line-Item 610 Salaries from the vacant Accountant**
10 **position and added to the Security Guard position to change the hourly wage from**
11 **\$9.74 per hour to \$9.98 per hour for a total annual salary of \$20,758.40; and**

12 **WHEREAS, \$124.38 has been taken out of Line-Item 620 Fringe Benefits from the vacant**
13 **Accountant position and added to the Security Guard position to cover Social Security**
14 **Expense, Workmen's Comp., Health & Unemployment, Life, Medical & Dental**
15 **Insurance; and**

16 **WHEREAS, the correction does not change the base budget amount for the FY 08 Gu-Vo District**
17 **Budget.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
19 **Tohono O'odham Legislative Council Resolution No. 07-641 titled "Approval of the Gu**
20 **Vo District FY 2008 Budget in the Amount of \$1,192,981.78" to use salary and fringe**
21 **savings from an Accountant position to correct the salary and fringe for one of its**
22 **District Security positions retroactive to October 01, 2007, per attached budget.**

23 **BE IT FINALLY RESOLVED that any amendments or modifications to the FY 08 Gu-Vo District**
24 **Budget must be submitted to the Gu-Vo District Governing Council, the Tohono**
25 **O'odham Legislative Council Budget & Finance Committee and the Tohono O'odham**
26 **Legislative Council for approval.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH. Day**
28 **of APRIL, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
29 **-0-NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2)**
30 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
33 **Stat. 984).**


