

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance, Food Distribution FY08 Program Budget for a Replacement Vehicle)**

RESOLUTION NO. 08-189

1 **WHEREAS, the Food Distribution Program delivers commodity food to communities on and off**
2 **the Nation through a tailgate distribution system; and**

3 **WHEREAS, on May 07, 2007, two staff were traveling to Eloy, Arizona to deliver commodity foods;**
4 **approximately one-half mile from Chui Chu, staff pulled to the side of the road to**
5 **check the vehicle for malfunction. The Pinal county Sheriff stopped as he noticed fire**
6 **under the chassis. The Commodity Delivery Coordinator used the fire extinguisher;**
7 **however could not extinguish the fire. The Sheriff and the workers moved at a distance**
8 **from the vehicle before it burst into flames. The vehicle burned completely; and**

9 **WHEREAS, the Food Distribution Program requires a replacement vehicle to deliver commodity**
10 **foods to communities on and off the Nation; and**

11 **WHEREAS, an insurance payment in the amount of \$3,265.00 was received and \$21,735.00 is**
12 **requested to purchase a replacement vehicle for a total of \$25,000.00; and**

13 **WHEREAS, Executive Director Budget is cost sharing a contribution of \$5,500.00 for the cost of the**
14 **replacement vehicle. The insurance payment of \$3,265.00 will be applied to the cost**
15 **of \$25,000.00, and the remaining will be cost shared between Health Transportation,**
16 **Community Health, Child Welfare; and**

17 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
18 **Division, Food Distribution Program has submitted for review and approval, the**
19 **proposal and budget in the amount of \$25,000.00.**

20 **NOW, THEREFORE ,BE IT RESOLVED that the Tohono O'odham Legislative Council Approves and**
21 **authorizes the FY08 Food Distribution Program vehicle replacement budget attached**
22 **in the amount of \$25,000.00, with funds from the insurance payment of \$3,265.00 and**
23 **contribution from the Department of Health and Human Services Executive Director**
24 **Budget of \$5,500.00.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes any**
26 **designated official to expend and administer the budget as attached, provided that**
27 **any amendments affecting the funds or funding level shall be submitted for further**
28 **prior approval by the Tohono O'odham Legislative Council.**
