

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Sells District Administration Fiscal Year 2008 Budget Amendment #2
and the Fiscal Year 2008 Big Field Budget Amendment #1)**

RESOLUTION NO. 08-194

1 **WHEREAS, Sells District Council approved Sells District Administration Budget FY 08 Amendment**
2 **#2 with Resolution No. SD-10-08 and the Fiscal Year 2008 Big Field Budget Amendment**
3 **#1 with Resolution No. SD-24-08; and**

4 **WHEREAS, Sells District Administration Budget FY 08 Amendment #2 creates three new positions**
5 **in line item 610, a Receptionist, a Payroll Technician and a Human Resource**
6 **Technician, increases the salary for the Vice Chairperson and Administrative**
7 **Secretary, and adds on the cost of living for one for the Community Resource positions;**
8 **and**

9 **WHEREAS, the gaming distribution for Sells District is \$1,192,981.78 for fiscal year 2008. Interest**
10 **of \$15,796.43 is added to the original amount for a total amount of \$1,208,778.21. The**
11 **interest of \$15,796.43 is added to line item 852 Donation/Contributions; and**

12 **WHEREAS, other line items that are affected included line item 640 Committee fee, 720 office**
13 **supplies, 778 alteration/renovations, 779 construction, 780 contingencies and 810**
14 **professional service for a total increase within the 2008 budget \$154,053.02; and**

15 **WHEREAS, the Budget Amendment #1 for Big Fields (Big Field) for FY 08, adding line item 710**
16 **Utilities, increasing line item 612 Occasional Appointment and line item 865**
17 **Emergency Assistance, and will decrease line items 280, 625, 720, 721, 727, 759, 772, 810,**
18 **855, 860, and 900 to cover the increased line items for a total of \$7,400.00.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
20 **Sells District Administration FY 08 Budget Amendment #2 in the amount of \$15,796.43**
21 **which is the interest from Gaming Increasing the original Gaming Distribution of**
22 **\$1,192,981.78 for a Grand Total of \$1,208,778.21 and the Fiscal Year 2008 Big Field**
23 **Budget Amendment #1 adding new Line Item #710.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
25 **Chairperson and any designated official to expend and administer the budget, as**
26 **attached, provided that any modifications/amendments affecting the funds or funding**
27 **levels of the budget shall be submitted for further prior approval by the Tohono**
28 **O'odham Legislative Council.**




