

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Clarence Miguel to the Election Board)**

**RESOLUTION NO. 08-200**

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power to appoint members**  
2 **of the Tohono O'odham Election Board pursuant to Section 1(B) of Article II of**  
3 **Ordinance No. 03-86, the Uniform Election Ordinance ("Election Ordinance"), which**  
4 **states, "Members of the Election Board shall be appointed by the Tohono O'odham**  
5 **Council for terms of five years, or until their successors are appointed and qualified";**  
6 **and**

7 **WHEREAS, the Election Ordinance further requires "that appointments to the board shall be**  
8 **made in such a way and for such terms that their terms shall be staggered so that the**  
9 **term of office of only one member will end in any single year."; and**

10 **WHEREAS, on July 31, 2007, Election Board Member Clarence Miguel's term did expire and he**  
11 **continues to serve as a Board member until his successor is appointed; and**

12 **WHEREAS, in compliance with the Election Ordinance, the Legislative Council has the authority**  
13 **to appoint a successor who will complete the five-year Election Board term that will**  
14 **expire July 31, 2012; and**

15 **WHEREAS, the Rules Committee, having legislative oversight of the Election Board, has**  
16 **interviewed qualified bilingual members of the Nation to serve the remainder of this**  
17 **term; and**

18 **WHEREAS, the Rules Committee recommends that Clarence Miguel be appointed to the Election**  
19 **Board to complete the five-year term ending July 31, 2012.**


20 **NOW, THEREFORE, BE IT RESOLVED the Legislative Council hereby appoints Clarence Miguel as**  
21 **a member of the Election Board upon the effective date of this resolution to complete**  
22 **the five-year term ending July 31, 2012.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup> Day**  
24 **of APRIL, 2008 at a meeting at which a quorum was present with a vote of 2,443.95 FOR; 90.55**  
25 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**  
26 **Section 1 (g) of Article VI and Section 7 of Article X of the Constitution of the Tohono O'Odham**  
27 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
28 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
29 **of the Act of June 18, 1934 (48 Stat. 984).**


