

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing the FY 2008 Department of Health and Human Services, Family Assistance
Division - Budget Amendment #1 - Account No. 01-1300)

RESOLUTION NO. 08-228

1 **WHEREAS, in FY2005 the Tohono O'odham Nation, Executive Office transferred from their budget,**
2 **\$55,000.00 to provide burial assistance services to members who are not eligible for**
3 **these services through the BIA P.L. 93-638 Social Service Contract; and**

4 **WHEREAS, the Department of Health and Human Services has recognized the increased need in**
5 **the costs of burial assistance services and the number of individuals requiring these**
6 **services; and**

7 **WHEREAS, the following table indicates the number of burial assistance services that were**
8 **provided for, FY2006, FY2007 and FY2008 (October 2007 through February 2008); and**

12 **WHEREAS, in the second quarter of FY08, funds were depleting for Tribal Burial Assistance**
13 **services. The projection for the remaining year (April 01 through September 30, 2008)**
14 **is based on an average of 3 burial assistance applications per month, (see attachment);**
15 **and**

16 **WHEREAS, the Executive Branch developed and obtained committee approval of the Family**
17 **Assistance Division, Tribal budget amendment #1 to increase the Wake Assistance line**
18 **item by \$100,000.00 for a total of \$155,000.00 which is attached and incorporated by**
19 **this reference, to be effective October 1, 2007 through September 30, 2008, and**
20 **requests authorization to expend funds. The fund source is the FY08 tribal surplus**
21 **funds.**

22 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
23 **approve and authorize the Executive Branch to expend funds in the amount of**
24 **\$100,000.00 from the FY08 tribal surplus funds, for the attached FY 2008 Family**
25 **Assistance Tribal budget amendment #1 for a total of \$190,531.64 effective October 1,**
26 **2007 through September 30, 2008.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairperson and**
28 **any designated official are hereby authorized to negotiate, execute and expend funds,**
29 **provided however, that any amendments affecting the funds or funding levels shall be**
30 **submitted for further prior approval by the Tohono O'odham Legislative Council.**
