

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of Budget Amendment #1 for Adult Protective Service Division salary  
increases from FY 2007 to FY 2008 wage scale)**

**RESOLUTION NO. 08-229**

1 **WHEREAS, the Tohono O'odham Legislative Council adopted Resolution 08-072 for Adult**  
2 **Protective Service Division; and**

3 **WHEREAS, in processing job descriptions through Human Resource Department, it was identified**  
4 **that the salaries for the positions in the approved budget through resolution were at**  
5 **the FY 2007 wage scale; and**

6 **WHEREAS, this budget amendment will change from the FY 2007 salaries to the FY 2008 wage**  
7 **scale.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
9 **the Amendment of the Adult Protective Services Division position salaries and fringe**  
10 **benefit increases from the FY 2007 wage scale to FY 2008 wage scale which is an**  
11 **increase of \$26,770.74 taken from professional services line item.**

12 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes any**  
13 **designated official to expend and administer the budget as attached, provided that**  
14 **any amendments affecting the funds or funding level shall be submitted for further**  
15 **prior approval by the Tohono O'odham Legislative Council.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup> Day**  
17 **of MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
18 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1(d)(2**  
19 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
20 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
21 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
22 **Stat. 984).**
