

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Financial Assistance)**

**LEGISLATIVE ORDER NO. 08-244**

1 **WHEREAS, the Legislative Branch FY 2008 budget permits the Branch officers to make**  
2 **contributions/donations in amounts not to exceed \$800.00 unless the full Legislative**  
3 **Council gives its approval; and**

4 **WHEREAS, the Legislative Branch has received a request for \$2,936.92 from Ramon Reyna for**  
5 **travel to Washington, D.C. for "Warrior Run" which composes of Veterans; and**

6 **WHEREAS, the Executive Office has agreed to cost share the amount of \$2,936.92; and**

7 **WHEREAS, the Legislative Branch's share will be in the amount of \$800.00 from the Donation line**  
8 **item and \$668.46 from the Public Relations line item for a total amount of \$1,468.46.**

9 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**  
10 **authorizes and directs the Legislative Branch Administration to issue payment in the**  
11 **amount of \$800.00 from the Donation line item and \$668.46 from the Public Relations**  
12 **line item for a total amount of \$1,468.46.**

13 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup>. Day of**  
14 **MAY, 2008 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST; -0-**  
15 **NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section**  
16 **1(d)(2) of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation**  
17 **on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
18 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
